Tipalti is a global remittance company that provides a comprehensive system of payments. This new service will allow you to **transfer your royalties** directly to your bank account (wire transfer) or receive an e-check, track your payouts with ease, and receive them faster.

Remember: Tipalti is a new additional method and, if you are comfortable with previous methods of payments you can continue to use them. The minimum amount to use Tipalti is US\$ 200 (two hundred US dollars).

There are steps that you need to setup your account:

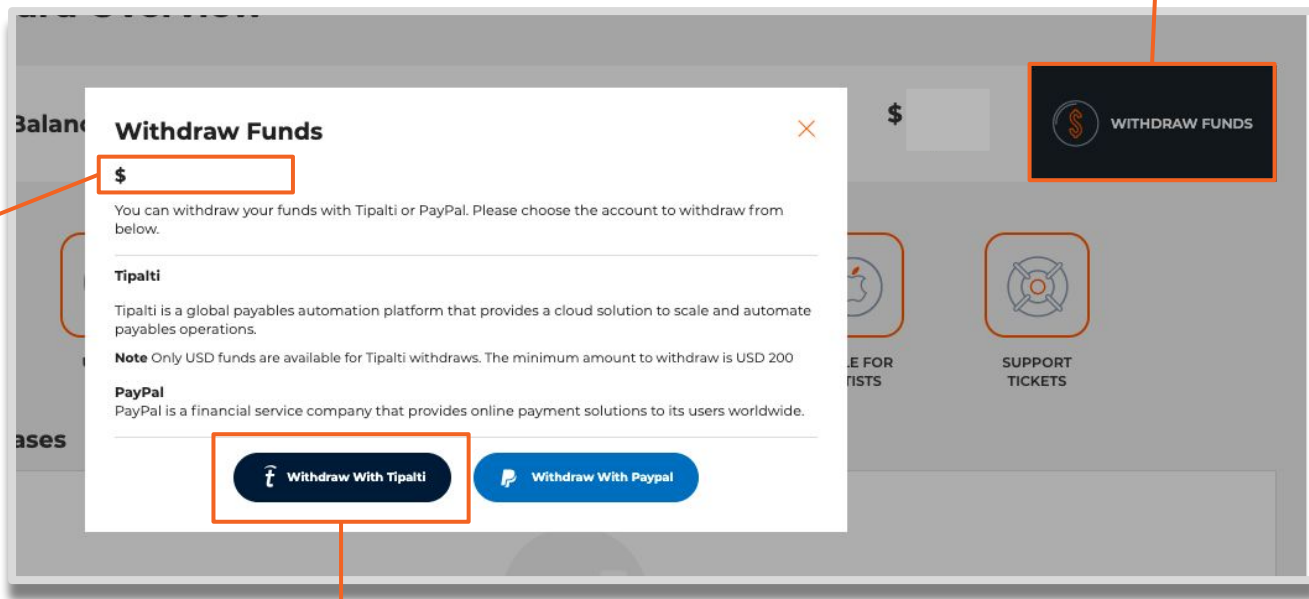



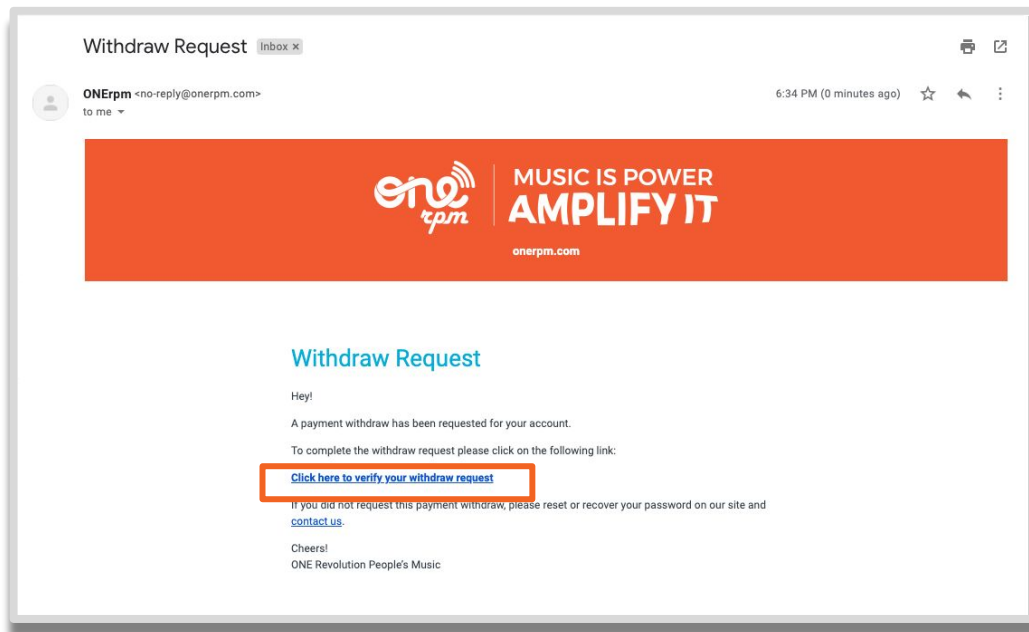
